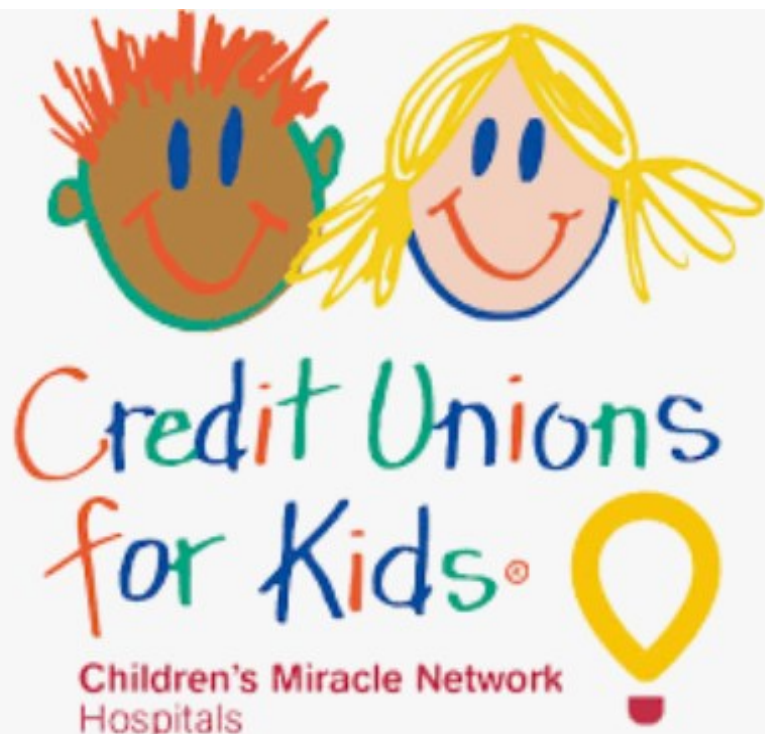
Holiday Skip A Payment

You may make up to one donation for each loan you have with Great Plains. Mortgage loans are not eligible for deferrals. Deferrals are subject to annual and loan term maximums.
